3. Discussion Items

3.1. CPC – 11/07/17 meeting

3.1.1. Geoff Green gave a presentation about the Promise and a discussion followed. New legislation, AB 19, the California College Promise, was also discussed. AB 19 allows California schools to individually decide if they will participate in the program or not. Money hasn't been assigned yet for AB 19. This new legislation will cover the tuition for any students who are entering college for the first time. The BOGG Grant has been renamed the Promise Grant. Participation in Guided Pathways is a requirement for colleges who want to participate in AB 19. The Santa Barbara Foundation Promise covers two years of college for local high school students and pays for tuition as well as books. SBCC may participate in both Promises.

3.1.2. Adam Green gave a presentation to CPC on the Sustainability Plan. The group meets 11-2 on Thursdays; staff, faculty, administrators, students and managers are welcome to participate. The Sustainability Plan has many goals and some have already been achieved. One big goal of the plan is to reduce waste by 25%.

3.1.3. Lydsay Maas gave a WRAP report to CPC. All positions requested (not faculty) have been ranked. The ranking rubric can be viewed on the CPC web site. These results need to be merged with the Academic Senate faculty ranking for replacements. The Director of Facilities wasn't included. There will be another ranking in April 2018.

- 3.1.4.** Grant funded positions will be discussed at the next CPC meeting. Permanent classified employees who are layed off after 1 year (due to a Grant funded position ending) are still eligible to be hired in another position when it opens. If a position opens the layed off classified employee must be given priority over other applicants.
