# PHILOSOPHY CLUB CONSTITUTION

### ARTICLE; I -NAME

The name of this club shall be the "Philosophy Club of Santa Barbara City College."

# ARTICLE II -

- a. To further understanding of philosophy and related fields by promoting the exchange of various viewpoints.
- b. To promote leadership, self-government and cooperation by involving students in club organization and activities.

### ARTICLE III -MEMBERSHIP AND DUES

The membership is open to any Santa Barbara City College student interested in the aims and objectives of the club as stated above.

- Section 2. The dues will be 5c cents (\$050 upon joining the club per semester, and are payable
- Section 3. The privilege of holding office, introducing motions, debating and voting shall be limited to members whose current dues are paid.

#### AHTICLE IV -OF¥ICERS

Section 10 The officers of this club shall be a president, vice-president, secretary, publicity chairman and treasurer.

- a. Officers shall be nominated and elected at the second meeting of each semester and shall form the administrative committee of the club.
- **b.** The faculty-sponsor shall preside over the first meeting of each semester, which will serve to introduce new members to the club and to each other.
- c. The faculty-sponsor shall appoint an acting chairman for the second meeting who will preside until the new president is elected.

#### ARTICLE V -DUTY OF OFFICERS

The president shall preside at ell meetings And shall perform such other duties as may be assigned to him by the club. He may delegate the responsibility of securing speakers and meeting places to 8ny member of the club.

Section 2. The vice-president shall act as aid to the president and shall perform the duties of the president in the 13bsence of that officer.

#### ARTICLE V -DUTY OF OF FICERS

The secretary shall keep an accurate record of all meetings and perform such other duties as may be delegated to that officer.

The publicity-chairman shall be in charge of all publicity and news releases. He will serve as the contact person for local radio.

The treasurer shall receive all monies of this club; shall keep an accurate record of receipts end expenditures; shall payout local funds only as authorized by the club; shall present a statement of account when requested and shall make a full financial report at the final meeting of the semester.

#### ARTICLE VI -MEETINGS

The officers of the club will meet in committee once a week with the president presiding. Time and place is to be determined by the committee at the beginning of each semester.

Regular meeting of the club shall be called once a month, time and place to be decided by the committee. Special meetings may be called as needed.

Specific dates for speakers and debates, usually to be held in private homes, are to be decided by the president in committee sessions.

The treasurer is to be informed as to the refreshment needs at home meetings.

### ARTICLE VII -AMENDMENTS

An amendment having been presented at a previous meeting of the club shall be paused by a 2/.3 vote of the membership.

# ARTICLE VIII-PARLIAMENTARY AUTHORITY

In all matters not covered in its constitution and by-laws this organization shall be governed by the Students Standard Code of farli8mentary Procedure.
