3.0 Discussion Items

3.1 Request to upgrade the word processor position to a faculty resource specialist.

This issue has come before the council on several occasions over several years. Dr. MacDougall indicated that he and Dr. Friedlander reviewed the history of the request. The original proposal that came from the Faculty Resource Center requested that at least one of the word processor positions be changed to reflect functions that were consistent with what the new FRC would be doing and not consistent with the traditional role that had been assumed in those positions. The Academic Senate, at that time, did not support that change, primarily based on the concern that they might be sacrificing needed work processing. Subsequently, when the position came as a sole position and not as part of a reorganization, I did not support its approval because it was not consistent with the criteria that since that time has been shared with CPC. Here to primarily to make clear the basis for the decision is that when the reorganization was proposed, this was seen as a necessary step to be taken.

3.2 Institutional self study update: Andreea Serban

Dr. MacDougall discussed the chart (*Attachment #3*) developed outlines drivers and processes for writing the self study. When we spoke to the Commission, we told them we would define our view of what a model community college is. We would identify a plan by which the college would move toward achieving our vision of a model community college in terms of goals and objectives. The second outcome as part of our accreditation work, would be that we would develop a system for assessing our effectiveness as a model community college. Dr. MacDougall told the council that we are making excellent progress toward the achievement of those objectives. Some of the areas of focus identify areas of focus for the 21st Century that we're necessarily that prominent in the 20th Century. For example, technology has revolutionized how we communicate with one another and how we carry out the work processes that we have. We need to reflect how we use technology to carry out means. The way I see the chart used is how do we assess whether we have developed goals and objectives that move this institution forward for the 21st Century by using the drivers and processes.
