Student Equity Committee (SEC) Meeting Summary January 30, 2015

Attended: Jack Friedlander, Oscar Zavala, Dolores Howard, Ignacio Alarcon, Clara Oropeza, Alice Perez, Kenley Neufeld, Ben Partee, Kelly Lake, Ethan Bertrand- Student Rep, Chelsea Lancaster, Jan Schultz, and Marsha Wright.

The Committee removed from the resource requests it received those that are funded from SSSP or from the STEM Transfer Success Program and the iPath Transfer Success Program. The Committee agreed to evaluate the results of these grant funded programs at the time they are about to expire to determine if future student equity funds should be allocated to institutionalize these programs.

The Committee approved seventeen SEC requests for funding totaling \$886,891 (Attachment 1).

The committee voted to commit funds from the college's 2015-16 student equity allocation to institutionalize the Express to Success Program. The total amount the committee committed from the college's 2015-16 student equity allocation to institutionalize ESP is \$334,000.

Institutional researcher was added to the list at \$140,000. Student Equity would pay for \$70,000 and SSSP funding would pay for the reminding \$70,000. Since the classification of this position has not been finalized, the funds needed to pay for this position may deviate from the amount approved by the committee. Ben Partee agreed to ask the SSSP Committee to approve the funding for 50% of the total costs of this position.

SSSP is covering costs for the TAP counselor and the EOPS counselor, the Admissions and Outreach SPA position, and short-term hourly funds to support student outreach and orientation.

SEC approved one counselor for local area high school caseload.

The committee approved requests totaling \$886,891 which is \$80,885 more than its 2014-15 student equity allocation. Since the counseling and classified staff positions were budgeted for the 2014-15 year, a significant amount of the money allocated to these positions will not be expended by June 30, 2015. Therefore, the committee agreed that the unspent money that was allocated for these positions would more than be enough to cover the difference of \$80,885 that was in excess of its 2014-15 allocation. The committee agreed to commit \$80,888 from its 2015-16 student equity fund allocation. Based on the governor's proposed budget for 2015-16, it is estimated that the college will receive an additional \$800,000 or so to support its student equity plan implementation over and above the \$806,006 allocation it has been granted in 2014-15.
